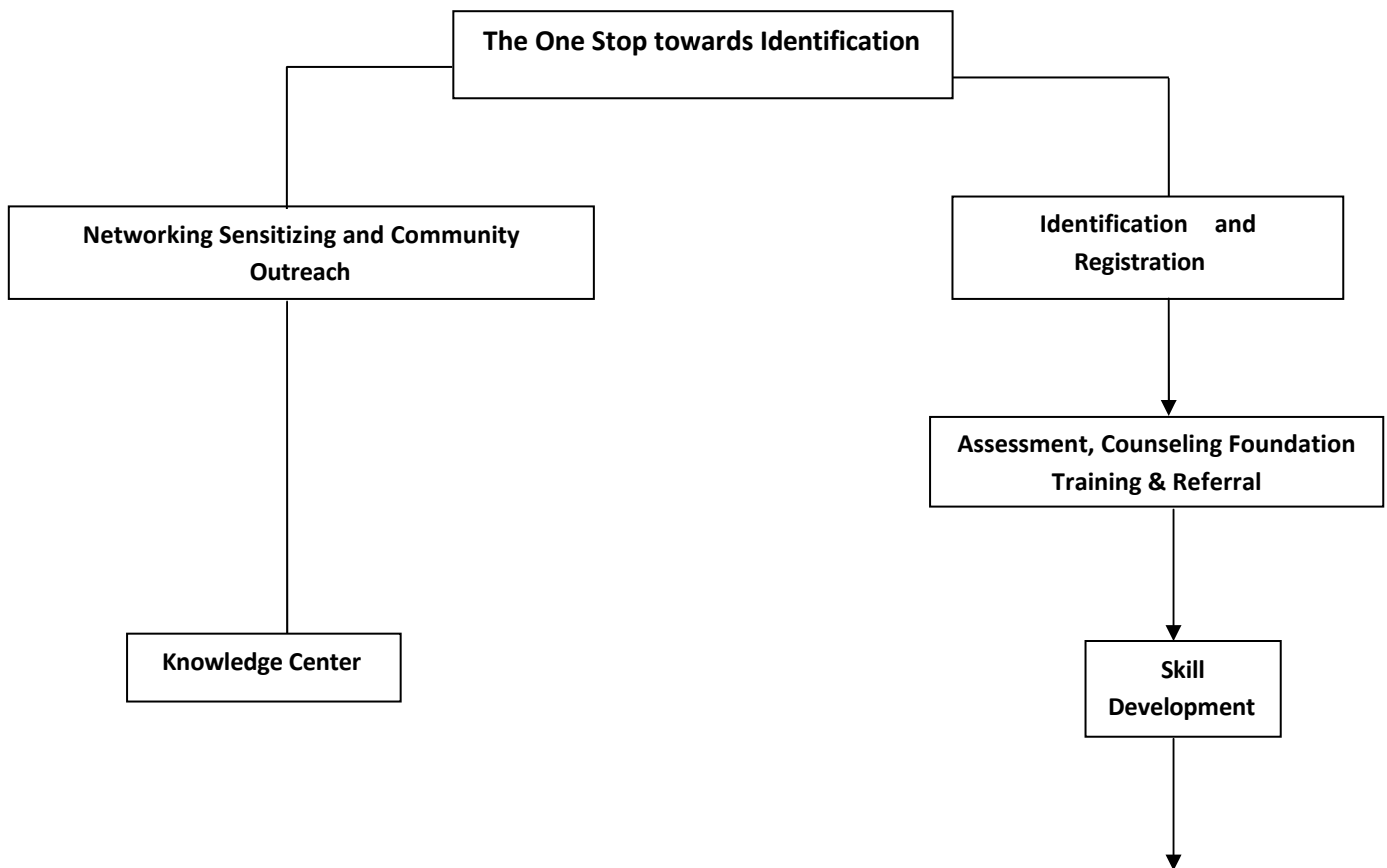

Viklang Sahara Samiti Delhi (VSSD) is a Non-Government organization working towards the Welfare and Education of Person with Disabilities (PwDs) coming from economically and socially deprived background since 1994 .VSSD had observed while working at the grassroots level that most of the Person with Disabilities in the society are not able to utilize the basic facilities offered by the Central/State Government. Therefore, VSSD established under Society Act and became a Social Organization in December 1994, to support and fulfill the needs of people with disabilities in the society. This support is in terms of Basic Education, Skill Training, Vocational Training and Placement etc. VSSD has successfully implemented its projects and goal oriented Programs to help the Person with Disabilities of all the types.

VSSD ensures providing opportunities to every PwDs and underprivileged youth irrespective of their caste, creed, gender, religion, status, etc. provided with quality of Vocational Training and proper guidance in an appropriate environment for their overall growth. Recently, our Vocational Training Centers are reaching towards their respective targets of providing committed services to PwDs and with an aim to empower them socially and economically through gainful employment. For that, we are making our efforts to build skills through Vocational Training to the students of the rural as well as the slum areas of Delhi and NCR.

Our Organization has an elaborate vision for providing equal opportunities to the Person with Disabilities and Underprivileged pool of Youth for their active participation in the society and to provide them with a common platform to access entitlement. The key focus of “VIKLANG SAHARA SAMITI DELHI” is to raise awareness for Inclusive Development and Education to Person with Disabilities and Youth from economically and socially deprived sections of Society by providing them is equal opportunities for their full participation so that they can share the same platform of entitlement as entitled to general in society.

- To provide Vocational Training to Youth for developing the commercial skills along with the traditional education.

- To create livelihood opportunities for Persons with Disabilities.
- To prepare candidates for interviews during their training program and move a step forward towards Sustainable Development.
- To take care of their mental health by giving them proper counseling from time to time and boost their will to make change in society.
- To work in areas of human rights awareness, protection from exploitation.
- To educate them about the various government programs created for the upliftment of the PwDs people so that they can be well aware of their rights, benefits, and subsidies which will ease their livelihood.
- Bring about a positive change in the attitude of Communities, Industries/Corporate, and stakeholders towards Persons with Disabilities and bring them into Mainstream.
- Equitable access to livelihoods and employment for People with disabilities.

AREA OF INTERVENTION & TARGET POPULATION

"Viklang Sahara Samiti Delhi" provides services to rural and slum areas of Delhi/NCR & 200km radius of outside Delhi/NCR i.e. U.P, Rajasthan, Haryana, Punjab & Madhya Pradesh.



VSSD works for the upliftment of People with Disabilities (PwDs), Underprivileged Youth and Senior Citizen/Widows who have limited resources due to low economic income, other limitations in society within the areas of social, economical, domestic, personal, and cultural development. These people are directly or indirectly benefited from the services of the organization.

OPERATING INFRASTRUCTURE

The Registered office of the organization is located in Delhi where adequate infrastructure is available for conducting meetings, staff canings, and management of program implementation. In addition to it, the society process field/project offers at different places in Delhi, which help the organization implementing the activities and monitoring the implementation of programs at the grassroots level and send periodical reports to its Administrative office. Followings are the salient features pertaining to Viklang Sahara Samiti Delhi, Operational Management:-

- Viklang Sahara Samiti Delhi has 4 project centers in Delhi.

CURRENT PROJECTS

SKILL DEVELOPMENT TRAINING:-

Viklang Sahara Samiti Delhi (VSSD) is focusing on providing the Vocational Training to Youth for developing the commercial skills along with the traditional education for Employment, which plays a significant and remedial role in balancing the socio-economic conditions of the individuals or their families. VSSD ensures that every Person with Disabilities and Underprivileged Youth irrespective of their caste, creed, gender, religion and category must be provided with quality Vocational Training and proper guidance in an appropriate environment for their overall growth and empowerment.

Currently, our Vocational Training Center beneficiaries numbers reached approx. 14474 of those have taken the quality training. These trainings are evaluated through examination, duly conducted by their respective instructor and support for providing job in such programs for which purposefully our organization enrolls students covering most of the rural and slum Areas of Delhi NCR.

SELF-EMPLOYMENT (APNA ROZGAR YOJNA):-

Through Viklang Margdarshan Kendra regular guidance for Self-Employment Scheme is being offered to Persons with Disabilities who belong to Economically Weaker Sections. Also under Apna Rozgar Yojana (ARY) program needy PwDs and individual youth who are illiterate unskilled and jobless are taken care. Till now 4515 beneficiaries are assisted through ARY program and these beneficiaries are earning between Rs. 100 to 300 per day. Further The ARY is extended its programs to support more heads as “Dhaba” “Pan stall” “cobbler (mochi)” “General store” “Tailor” “vegetable selling” “Mehandi stalls” etc.



Self-Employment Project aims to create the demand of the skilled workforce of persons with disability in various industries by way of carrying job mapping drives and making the candidates competent and skilled to perform the job. Self-Employment helps in defining an individual's place in the community especially to help the disabled citizens live a normal dignified and independent life.

UDAAN SPECIAL LEARNING SCHOOL

Udaan Special Learning School is a dedicated educational institution established to serve children with special abilities. The school is managed by Viklang Sahara Samiti Delhi in collaboration with Tata Power Delhi Distribution Limited, and is located at TPDDL Sub-Station Building, front of House No. 56, Pocket 16, Sector 22, Rohini, Delhi-110085. Among its core objectives, Udaan provides a supportive and inclusive environment tailored to meet the individual needs of its learners. It features infrastructure such as accessible ramps, wide corridors, specialized classrooms, a playground, and a sensory room to promote physical activity and sensory-stimulation. The school's curriculum emphasizes individualized learning plans, integrating special educational interventions, assistive technologies, and therapy-based support (occupational therapy, physiotherapy, speech therapy) to maximize each student's potential. In addition to academic instruction, Udaan fosters social integration and community participation. By nurturing essential life skills, vocational readiness and therapeutic support, the school aims to enable children with special abilities to grow with confidence, independence and a sense of belonging.



DISTRIBUTION of AIDS/APPLIANCES:-

- To arrange full rehabilitation management for Divyangjan like:-surgery/mobility, Aids/Appliances like- Caliper, Crutches, Tricycle, Wheel Chair, stick and other appliances.
- Collaborate with various Govt. or Non-Govt. Organizations to facilitate supportive devices for daily living through camps in different areas. Till now **14532** beneficiaries benefitted through this service.

LOANFORSELF-EMPLOYMENT:-

Loan with no interest is being provided to set up a small business to individuals and Self-Help Groups (SHGs) with disabilities and unemployed youth, so as to provide them a chance for self-sustainability. Loan facility is being provided in collaboration with Delhi SC/ST/OBC/Min. & Handicapped Finance & Development Corp. Ltd and National Divyangjan Finance and Development Corporation.

EDUCATIONALASSISTANCE:-

- Help in getting admission in the Govt. Schools & provide Stationary to Children and Youth having Disability.
- Circulate Guidelines time to time to students for scholarship from U.T. & State Govt./NGO/Public.
- Provide Educational, Social Counseling and Guidance for their bright future.
- Registration with NIOS for X and XII Classes.



NIRAMAYA- HEALTH INSURANCE SCHEME OF NATIONAL TRUST:-

This scheme is for the welfare of Persons with Autism, Cerebral Palsy, Mental Retardation (Intellectual Disability) and Multiple Disabilities. Enrolled beneficiaries are being facilitated with Niramaya Policy for their treatment. Being a registered organization of National Trust, our staff is authorized for new/renewal cases.

LEGAL GUARDIANSHIP (LG)/LOCAL LEVEL COMMITTEE (LLC):-

LLC is a district-level committee constituted under Chairmanship of District Collector/District Magistrate to provide guardianship for Persons with Autism, Cerebral Palsy, Mental Retardation (Intellectual Disability) and Multiple Disabilities. VSSD is a LLC Member of North-west district.

EMPLOYMENT ASSISTANCE:-

Routine support is being provided to PwDs for their registration in Special Employment Exchange for Job fairs and Placement Service referred to Specialized Agencies.

MATRIMONIAL SERVICE:-

Viklang Sahara Samiti Delhi committed to serve their services to people with disabilities to choose a perfect life partner and lead a happy life. We are supporting them with open heart and try to give them greatest gift ever “A loving and caring life partner” to share their happiness & divide their sorrow. We understand their preferences and committed to find their compatible match. We aim to provide a platform where people with disabilities can come together to find a suitable life partner. VSSD started online form i.e. Marriage registration for PwDs across country whose purpose is to settle their life with their compatible partners and after the getting their applications for registration, Mega Sammelan organize time to time to find a suitable life partner.
